

ORDINANCE NO. 2017-3121

AN ORDINANCE PROVIDING FOR THE TEMPORARY CLOSING OF A PUBLIC STREET AND SIDEWALK AND FOR THE CONSUMPTION OF ALCOHOL AT A SPECIAL EVENT WITHIN THE CITY OF CONCORDIA.

BE IT ORDAINED by the governing body of the City of Concordia, Kansas:

SECTION 1. That part of Broadway Street adjoining Lot One in Block One Hundred Thirty-Five (135) in the City of Concordia, Kansas, also described as Broadway Street from 6th Street to the alley in Block 135, and the public sidewalk on the west side of Broadway Street adjoining that lot, shall be closed to vehicular traffic with suitable barricades from 6:00 a.m. to 11:00 p.m. on August 12, 2017, for a special event consisting of a Cloud County Community College Athletic Department Booster Club Kick-off Fundraiser, during which time access to the closed portion of Broadway Street and sidewalk shall be controlled by the Cloud County Community College Athletic Department.

SECTION 2. Alcoholic beverages shall be permitted to be sold and consumed within the closed areas of Broadway Street and the adjoining sidewalk on the west side of Broadway Street from 7:30 a.m. to 11:00 p.m. on August 12, 2017.

SECTION 3. The boundaries of the area described above shall be clearly marked by temporary fencing during the time permitted for consumption and sale of alcoholic beverages.

SECTION 4. No alcoholic liquor may be consumed inside vehicles while on the closed portions of Broadway Street during the special event as described in Section 1.


SECTION 5. This ordinance shall be summarized for publication as follows:

On May 17, 2017, the City of Concordia adopted Ordinance No. 2017-3121, providing that Broadway Street adjoining Lot One (1) in Block One Hundred Thirty-Five (135) in the City of Concordia, also described as Broadway Street from 6th Street to the alley in Block 135, and the sidewalk on the west side of Broadway Street adjoining that lot, shall be closed to vehicular traffic with suitable barricades from 6:00 a.m. to 11:00 p.m. on August 12, 2017, for a special event consisting of a Cloud County Community College Athletic Department Booster Club Kick-off Fundraiser, during which time access to the closed portion of the street and sidewalk shall be controlled by the Cloud County Community College Athletic Department, and also providing that alcoholic beverages shall be permitted to be sold and consumed within the closed areas of Broadway Street and the adjoining sidewalk on the west side of Broadway Street from 7:30 a.m. to 11:00 p.m. on August 12, 2017.

SECTION 6. This ordinance shall be in full force and effect from and after its passage and publication of the above ordinance summary. The provisions hereof are severable, and in the event of invalidity, for any reason, of any portion of this ordinance, the remaining provisions of the ordinance shall remain in full force and effect, with the invalid provisions deemed excised.




